

DOG WAIVER

By enrolling the above named dog(s), I represent that I am the legal owner and I assume all risks, dangers and responsibility for my dog(s) during their stay at Companions Pet Resort.

I represent that my dog(s) are in good health, current on all required vaccinations (Bordetella, Rabies, DA2PPV) and have not been ill to the best of my knowledge in the past 30 days.

I understand that while my dog(s) are fully vaccinated that vaccines are not 100% guaranteed and there is still a risk that my dog(s) may contract a contagious disease.

*****Canine infectious tracheobronchitis also referred to as 'kennel cough' is a highly contagious respiratory disease spread amongst dogs. This can be found anywhere large numbers of dogs are housed or come in contact with each other (boarding facilities, grooming salons, vet clinics, pet stores, dog parks). I understand that although my dog(s) are vaccinated with the Bordetella vaccine it is still possible to get 'kennel cough'. I understand that the Bordetella vaccine only protects against some strains of the disease. I understand the risks while my dog(s) are in the care of Companions Pet Resort and will not hold Companions Pet Resort liable should my dog(s) become infected.*****

Companions Pet Resort recommends that all dogs be on Veterinary approved flea and tick prevention during high risk months (weather dependent). I understand that there is a risk of tick exposure if I give permission for my dog(s) to go on trail walks. I understand that if my dog(s) are found to have a flea infestation they will be taken to a licensed Veterinarian for appropriate treatment at my own expense and I will be charged an appropriate fee to have the environment cleaned to prevent risk to other guests.

I understand that during normal dog play, my dog(s) may sustain injuries. All dog play is monitored by Companions Pet Resort staff to avoid injury or fights, but scratches, punctures, torn ligaments and other injuries may occur despite supervision and I will not hold Companions Pet Resort liable. If my dog(s) require medical attention I understand I am responsible for my own dogs expenses.

I understand that if I allow my dog(s) to join group play there is a higher risk of injury due to 'rough housing', running, wrestling or fighting. If my dog(s) are injured during group play I assume all risks and cost associated with the injury should my dog(s) need medical attention. Although Companions Pet Resort staff do their best to match dogs with 'like' personalities and size there is always a greater risk of injury or fights during group play. I fully understand the risk associated with group play and assume all responsibility.

*****I understand that my dog(s) will be assessed for their behaviour and only allowed to join group play as deemed appropriate by Companions**

I give permission for Companions Pet Resort to use my dog(s) photos on Facebook, in marketing material or on their website.

I, the Owner, hereby certify that I have read and understand the rules and terms set forth by Companions Pet Resort and release them of all liability. This waiver is considered valid for one year after signing.

Pet Resort staff. Group play is for those dogs that are already known to be social and get along with other dogs. Companions Pet Resort maintains a safe environment for all their guests and will not use social dogs to 'test or train' unsocial dogs. If my dog(s) are unfamiliar to group play, Companions Pet Resort will allow them to meet other social dogs if deemed appropriate. If my dog(s) show any sign of aggression or inappropriate play (bullying, humping, guarding, etc) Companions Pet Resort will not allow them to continue in group play and they will only have individual play. I understand that Companions Pet Resort has the right to make the decision of group play or individual play based on individual dogs. If my dog(s) are known to be unsocial or aggressive with other dogs I will not request group play. ***

I allow Companions Pet Resort staff to contact my Veterinarian as deemed necessary to discuss my dogs health, medical issues or vaccination status during their stay. Should my dog(s) require medical attention I understand that I will be responsible for any medical bills. I understand that Companions Pet Resort will take my dog(s) to the Veterinarian of my choice whenever possible. I give permission for Companions Pet Resort to take my dog(s) to a licensed Veterinarian of their choice should my Veterinarian be unavailable.

If Companions Pet Resort has any concerns about my dog(s) during their stay and I cannot be reached I give permission for them to contact my emergency contact. I give full permission to my emergency contact to make any decisions regarding my dogs health should I be unavailable. If Companions Pet Resort cannot reach me or my emergency contact I give them full rights to make any necessary decisions. If Companions Pet Resort needs to take my dog(s) to a Veterinarian I will reimburse them for the costs incurred for both the veterinary bill and staff/travel time.

If my dog(s) show signs of aggression towards a Companions Pet Resort staff member they may be asked to leave. If my dog(s) bite a Companions Pet Resort staff member I understand the incident will be reported to the Health Unit and my personal information and dogs vaccine status will be disclosed.

I understand that my dog(s) have access to secure outdoor enclosures as well as outdoor trail walks on a double leash system (if permission given). I understand that despite the safety measures in place at Companions Pet Resort there is a risk my dog(s) can escape and I assume all risks and will not hold Companions Pet Resort liable.

I understand that Companions Pet Resort is not responsible for any personal items left behind, being lost or damaged by my dog(s).

I understand that if I do not pick my dog(s) up at the scheduled departure time I will be charged for late fees accordingly. I agree that if my dog(s) are not picked up within 7 days of their scheduled departure date my dog(s) will be deemed abandoned and Companions Pet Resort has the right to surrender them to the appropriate authorities.
